#### I. CALL TO ORDER

 Motion made by Etienne Nortje to approve the application to install a screened patio as presented.
 Motion 2<sup>nd</sup> by Ashley Falvey. Motion Passed, unanimous all in favor.

#### IV. COMMITTEE CHAIRPERSONS REPORTS

1. Finance / Treasurer – Ashley Falvey reviewed the July 2022 financials and did not notice any discrepancies or concerns.

Common Grounds/WelcomeCommittee/SocialCommittee – The flags that were ordered for both entrances are scheduled to arrive on August 19, 2022.

The annual community Halloween event is scheduled for October 29, 2022.

Security Committee – Preston Davis reported there have been 19 incidents since the beginning of the year. He stated the cameras are effective. Many of the incidents have taken place at the dam.

# V. MANAGEMENT REPORT

Angela briefed the Board on the Management Report and weekly visits for violations. Board members with any specific violation concerns may email Angela with details and she will check it on her next site visit.

- <u>Legal</u>
  - Acct #219404 Settlement Offer Etienne Nortje made a motion to reject the settlement offer presented by the homeowner. Motion 2<sup>nd</sup> by Ashley Falvey. **Motion Passed**, unanimous all in favor.
- The board then proposed a counteroffer. Etienne Nortje made a motion to waive \$125 of the violation fees if the account is paid in full by September 30, 2022 and the fence violation is corrected. Motion 2<sup>nd</sup> by Jeanne Antolchick. **Motion Passed**, unanimous all in favor.

## VI. UNFINISHED BUSINESS

- Force Mow The Board discussed that sometimes various yards need mowed, both those on vacant lots, as well as some on currently occupied properties. Discussion included historical examples where the Board has used Force Mow actions in the past. A tentative procedure for Force Mow was proposed as follows:
  - o Step 1 − Yard is noted to be in need of moving, logged by CAM
  - o Step 2 CAM sends Force Mow notification to homeowner, with timeline to correct
  - o Step 3 CAM observes lawn still needs mowed, CAM contacts our landscaping company to mow the lawn, and posts mowing costs to homeowner's account

#### VII. NEW BUSINESS

• Waiver of Late Fees – **Motion made** by Ashley Falvey to waive late fees for homeowners that pay their assessments by August 31, 2022. **Motion 2<sup>nd</sup>** by Etienne Nortje. **Motion Passed**, unanimous all in favor.



- Business Calendar Jeanne Antolchick is working on a perpetual community calendar that can be updated yearly. Residents will be able to view the calendar on the Shadow Run website. Once completed, the calendar will be sent to the board for review.
- Policy Updates Jeanne Antolchick is working on reviewing the following policies and transferring them to the Shadow Run letterhead. The policies she is reviewing include:
- 1.) Deed Restrictions 2.) Delinquency Collection, 3.) Records Destruction and 4.) Records Inspection. Once completed, the policies will be sent to the board for review and approval.
