2025 Annual Membership Meeting Minutes

April 30, 2025 at 6:00 p.m.**

I. CALL TO ORDER

- a. Calling of the roll (Establish Quorum) **Etienne** Nortje called the meeting to order as there was a quorum of the membership present with >30% members present either in person or by proxy at 6:04 p.m.
- b. Certifying of Proxies – Owners to include Darcy, Renee, Lonaye and Kelly certified the proxies received thus far.

II. PROOF OF NOTICE OF MEETING OR WAIVER OF NOTICE

The notice of meeting and agenda was posted as required by Association documents and Florida statutes. The Affidavit of Mailing was also shown to those in attendance.

III. READING AND DISPOSAL OF ANY UNAPPROVED MINUTES

A motion was made by **Jimmy** Selvey to approve the April 25, 2024 Annual Meeting Minutes as presented. The motion was seconded by **Tina** Holly. **Motion passed**, unanimous, all in favor.

IV. REPORTS OF OFFICERS

Discussion took place about the **dam** and the **lake**. High level updates were provided to the Membership regarding various ongoing efforts to achieve the Membership’s request to “Save to Dam to Save the Lake”, including attorney interactions, donations, plantings, erosion-control-grass, etc. A member asked about the survey results and it was communicated that the overwhelming majority of residents would support reasonable efforts and cost to preserve the future of the dam. VI. ELECTION OF INSPECTORS OF ELECTION

a. **Budget (2025/2026)**

The 2025/2026 Board adopted budget was voted on **and passed** by Membership in accordance with Bylaws Article VI, Section 3 as **246** members who voted, in person or by proxy, voted in **favor** of the budget and **5** voted **against**, in person or by proxy.

Annual assessment will remain at \$250 per parcel. This was certified by the owner volunteers to include Darcy, Renee, Lonaye and Kelly.

b. **Revitalized Community Covenants and Restrictions**

It was announced that *"Since we need 231 "yes" votes to pass the proposed changes to the governing documents, and since not enough members have yet voted on this issue, we are making a motion to recess and temporarily adjourn the portion of this meeting to another specific date and time to continue to seek proxies from Members who have not yet voted."*

Ashley Falvey made the following motion:

"I move that the membership recess and temporarily adjourn the portion of this meeting dealing with the proposed changes to the governing documents until the meeting of the Membership scheduled for May 29th, 2025, at 7:00 P.M. at this same location, to seek additional proxies and votes from members who have not yet voted."

Lee Alexander seconded the motion.

Motion passed, unanimous by those in person or by proxy.

VII. ANNOUNCEMENT OF NEW BOARD OF DIRECTORS

In accordance with Bylaws – Article III, Section II, Part D: "If there are fewer candidates than vacancies to be filled, the candidates who have been nominated shall be automatically elected to fill vacancies..." Accordingly, the new board of directors are **Michelle** Pearson, **Lisa** Tackus, **Ashley** Falvey, **Lee** Alexander, **David** Parker, **David** Tsang and **Etienne** Nortje since no other owners submitted a notice of intent by the deadline.
